(a) Amount Beneficially Owned:

As of the close of business on May 11, 2018, the reporting persons beneficially owned an aggregate of 677,741 shares of the Issuer's Class A Common Stock or 5.1% of the Issuer's Class A Common Stock outstanding.

Thereafter, as of the close of business on May 18, 2018, the reporting persons beneficially owned an aggregate of 588,927 shares of the Issuer's Class A Common Stock or 4.4% of the Issuer's Class A Common Stock outstanding. Specifically, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), beneficially owned 477,563 shares of the Issuer's Class A Common Stock and Integrated Assets II LLC, a Delaware limited liability company ("Integrated Assets II"), beneficially owned 111,364 shares of the Issuer's Class A Common Stock.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and Integrated Assets II and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

Millennium Group Management LLC, a Delaware limited liability company ("Millennium Group Management"), is the managing member of Millennium Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

Israel A. Englander, a United States citizen ("Mr. Englander"), controls the managing member of Millennium Group Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies and Integrated Assets II.

The foregoing should not be construed in and of itself as an admission by Millennium Management, Millennium Group Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies or Integrated Assets II, as the case may be.

(b) Percent of Class:

As of the close of business on May 18, 2018, Millennium Management, Millennium Group Management and Mr. Englander may be deemed to have beneficially owned 588,927 shares of the Issuer's Class A Common Stock or 4.4% of the Issuer's Class A Common Stock outstanding (see Item 4(a) above), which percentage was calculated based on 13,325,834 shares of Class A Common Stock outstanding as of March 26, 2018, as per the Issuer's Form 10-K dated March 30, 2018.
