The Class B Common Stock will convert automatically into Class A Common Stock on the same basis upon the earlier of: (i) any transfer, whether or not for value, except for certain "Permitted Transfers" as defined in the Issuer's restated certificate of incorporation, and (ii) at such time as the outstanding shares of Class B common stock represent less than 10% of the aggregate number of shares of the Issuer's capital stock outstanding.
- 2. The transactions were pursuant to a Rule 10b5-1 trading plan adopted by the reporting person.
- 3. The price reported is a weighted average price. The shares were sold in multiple transactions at prices ranging from \$80.70 to \$81.68, inclusive. The reporting person undertakes to provide to the Issuer, any security holder of the Issuer or the staff of the Securities Exchange Commission, upon request, full information regarding the number of shares sold at each separate price within the ranges set forth in this footnote
- 4. The price reported is a weighted average price. The shares were sold in multiple transactions at prices ranging from \$81.71 to \$82.26, inclusive. - 5. These shares are held by The Kevin P. Ryan 2012 Trust (the "Trust") for the benefit of the reporting person's children. The reporting person disclaims beneficial ownership of these securities, and the filing of this report is not an admission that the reporting person is the beneficial owner of these securities for purposes of Section 16 or for any other purpose.
- 6. The price reported is a weighted average price. The shares were sold in multiple transactions at prices ranging from \$80.91 to \$81.77, inclusive.
