**As of December 31, 2018: Mr. Ryan beneficially owned 2,795,905 shares of the Issuer's Class B Common Stock, of which (i) 1,833,739 are held directly by him and (ii) 962,166 are held by The Kevin P. Ryan 2012 Trust for the benefit of his children. The Class B Common Stock is convertible at the holder's option into the Issuer's Class A Common Stock on a 1-for-1 basis. The holders of Class B Common Stock are entitled to ten votes per share and the holders of Class A Common Stock are entitled to one vote per share.**

**Based on (i) 35,887,732 shares of the Issuer's Class A Common Stock issued and outstanding and (ii) 18,109,700 shares of the Issuer's Class B Common Stock issued and outstanding, in each case, as of December 31, 2018, as reported by the Issuer, and the information set forth in (a) above, Mr. Ryan beneficially owned 5.2% of the Issuer's outstanding Common Stock, representing 12.9% of the total voting power of the Issuer's outstanding Common Stock, and 7.2% of the Issuer's outstanding Class A Common**
