Item 4. <u>Ownership</u>.

(a) Amount Beneficially Owned: As of December 31, 2017 NEA 14 is the record owner of Common Stock and Class B common stock ("Class B Common Stock") as described below. As described in the Issuer's 10-Q, filed with the Securities and Exchange Commission on December 15, 2017 (the "10-Q"), holders of Class B Common Stock are entitled to ten votes per share while holders of the Common Stock are entitled to one vote per share. In addition, holders of Class B Common Stock and holders of Common Stock generally vote together as a single class. This single class would consist of 50,581,674 shares, which includes (i) 9,326,098 shares of Common Stock (the "10-Q Shares") and (ii) 41,255,576 shares of Class B Common Stock reported by the Issuer to be outstanding as of December 11, 2017 on the 10-Q. As further described in the 10-Q, each share of Class B Common Stock is convertible by the holder at any time into one share of Common Stock and each such share will convert automatically into Common Stock upon the occurrence of certain other events.

NEA 14 is the record owner of 150,000 shares of Common Stock and 2,928,185 shares of Class B Common Stock. As each share of Class B Common Stock is convertible by the holder at any time into one share of Common Stock, as described above, NEA 14 may therefore be deemed to own beneficially 3,087,185 shares of Common Stock (the "Shares"). As the sole general partner of NEA 14, NEA Partners 14 may be deemed to own beneficially the Shares. As the sole general partner of NEA 14 GP likewise may be deemed to own beneficially the Shares. As the individual Directors of NEA 14 GP, each of the Directors also may be deemed to own beneficially the Shares.
